

# GIK ACOUSTICS RED HOT ROCK ICON ACOUSTIC ART PANEL CONTEST OFFICIAL RULES

These official rules ("Official Rules") apply to the email sign-up Red Hot Rock Icon Acoustic Art Panel Contest ("Contest") offered by GIK Acoustics and GIK Acoustics-Europe.

All winners must be 18 years of age or older, unless otherwise stated and/or posted.

TO ENTER, YOU MUST COMPLETE THE ONLINE ENTRY FORM OR COMPLETE AN ORDER DURING CONTEST ENTRY DATES AND AGREE TO THE OFFICIAL RULES. SUBJECT TO ALL FEDERAL, STATE AND LOCAL LAWS AND REGULATIONS.

1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST.

2. VOID WHERE PROHIBITED.

3. ENTRY: The contest opens on September 20, 2018, at 12:01am EDT. There are two ways to enter into the Sweepstakes and become an eligible entrant ("Entrant"):

A). No incomplete, illegible or otherwise invalid entries will be accepted.

11. PRIZES: Twelve (12) Acoustic Art Panels 2" (24"x48") in the U.S. and twelve (12) Acoustic Art Panels 50mm (120 x 60) in Europe will be awarded. Acoustic Art Panels will be manufactured with "Red Hot Rock Icons" artwork. Prizes must be claimed by the prize winner within 48 hours of the prize winner being notified. By entering this contest, all entrants agree to all the terms listed here and refusal to participate or disregard any of the terms herein will result in immediate disqualification.

Each prize package is valued at \$398.00 USD / £310.00 GBP / €366.00 EUR
